Sir/Madam,

This is with reference to school application on the subject cited above. I am directed to convey the approval of the Board for Affiliation i.e Upgradation to Senior Secondary Level as per details given below :

Sl. No.	The school is directed to ensure that :
1	The total number of sections for Bal Vatika is restricted to 03 (01 each for Bal Vatika I,II & III respectively). Further, the total number of sections for classes 1st to 12th shall be restricted to 18 only out of which not more than 1/3rd sections may be used for senior secondary level classes. The optimum number of the students shall be restricted to 40 in each section. Any further increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law and availability of class rooms of 500 sq ft and greater in dimension.
2	The boundary wall of the school at main gate is not of appropriate size (preferably 6ft height) and can be scaled by outsider which concern for safety and security of the students and staff. School should have proper height of boundary wall covering the campus form all sides in compliance with the statutory provisions and the Board guideleins. School is directed to make compliance for such security and upload the compliance with video link on SARAS portal within 03 months.
3	Math lab has small work stations which are not recommended and suitable for project/practical works. Further, the stock is also less. School is directed to follow the Board guidelines notified vide SoPs and circular no 11/2022 and upgrade the math lab with recommended infrastructure and facilities and upload the compliance with vido link on SARAS portal within 03 months.
4	All the three science labs for senior secondary level are not seen with recommended safety measures like fire extinguishers, exhaust fans, safe gas fitting for heating facility etc. Further, work stations in Physics and Biology labs are also not proper and appropriate as per SoPs and Board guideleins as notified vide circular no 11/2022. School is directed to arrange and set up the labs as per strictly SoPs and upload the compliance with video link showing all labs with infrastructure with video link on SARAS portal within 03 months.
5	The size of CwSN toilets is small and entrance is also narrow to allow the wheelchair/walker inside with proper navigation and movement. School has not arranged the CwSN facilities including ramps etc as per statutory provisions of the RPwD Act and the Board guidelines vide circular no 05/2023. School is directed to re-arrange the CwSN toilets separately for boys and girls at each floor and upload the compliance with video link on SARAS portal within 03 months.

6	Indoor sports facilities be also arranged as per Board SoPs and guideline and compliance with complete video be upload on SARAS portal within 03 months.
7	School shall ensure the proepr safety and security for the students and shall always make compliance of all statutory provisions/directions issued by the appropriate Govt from time to time and also shall comply with the Board guideleins as issued. An affidavit for such compliance shall be uploaded by the management on SARAS portal within 03 months.
8	The school shall conduct training of its teachers with CoE Vijayawada, CBSE and submit the compliance on SARAS portal within 03 months

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
2. The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
3. The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.
5. The school shall renew mandatory certificates from time to time.
6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
7. Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.
8. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
9. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

If the compliance is not submitted with in the stipulated 3 months , the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
